

# RIOT (DAMAGES) ACT, 1886

- (1) "I" or "We."
- (2) Insert total sum claimed.
- (3) If the claim is not made under all the heads, the superfluous words should be struck out.
- (4) "me" or "us."
- (5) Insert the hour or hours at which the riot occurred.
